## SECTION 4: First aid measures

#### Description of first aid measures

##### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately.

Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

#### Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

#### Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

#### Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

#### Most important symptoms and effects, both acute and delayed

#### Indication of any immediate medical attention and special treatment needed

Symptomatic treatment of overdosage is recommended. Since aminoglutethimide and glutethimide are chemically related, measures that have been used in successfully removing glutethimide from the body might be useful in removing aminoglutethimide. ...Close monitoring should be provided, and appropriate measures taken to support vital functions, if necessary. If deficiency of circulating glucocorticoids develops, intravenous infusion of a soluble hydrocortisone preparation ... and glucose solution should be given within 3 hours. After initial infusion is complete, an intravenous administration of hydrocortisone, ... should be continued until the patient is able to take oral cortisone. If hypovolemia or hypotension occurs, an intravenous administration of norepinephrine ... in isotonic sodium chloride should be administered according to the patient's needs and response. After rehydration ... plasma or blood should be given for maintenance of sufficient circulatory volume. Dialysis may be considered in severe intoxication.

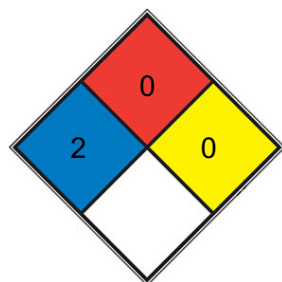

## SECTION 6: Accidental release measures

### Personal precautions, protective equipment and emergency procedures

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

### Environmental precautions

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

### Methods and materials for containment and cleaning up

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

Handling in a well ventilated place. Wear suitable protective clothing. Avoid contact with skin and eyes. Avoid formation of dust and aerosols. Use non-sparking tools. Prevent fire caused by electrostatic discharge steam.

Protect from light. Do not store above 30 deg F (86 deg C). Dispense in tight, light resistant container.
